Restrictions on the Ownership of Hospitals by Physicians

-advocates for AMA advocacy against any restrictions on creation of physician owned hospitals

Screening and Approval Process for the Over-the-Counter Sale of Substances with Potential for Recreational Use and Abuse

-advocates for development of a process for regulation of unregulated substances sold over the counter with abuse potential.
